Sodium Bicarbonate is a drug used to treat buildup of acid in the body. Midazolam is used to cause drowsiness before surgery. ELCYS (cysteine hydrochloride injection), USP is a drug used to provide nutrition. Our records show you may have gotten one or more of these drugs not long ago. You may need to take some action.

On October 25, 2023, Exela Pharma Sciences, LLC issued a recall of several lots of multiple products by Exela Pharma Sciences, LLC. This recall was issued due to particles being found in the products. Using an injection with these particles could result in irritation or swelling.
