We have important drug recall information about your prescription for Liraglutide Injection 6 mg/mL.

Our records show that you may have recently filled a prescription for this drug.

On May 19, 2026, the United States Food and Drug Administration (FDA) issued a Class II recall of certain lot numbers of Liraglutide Injection 6 mg/mL.

Lupin Pharmaceuticals Inc. issued this recall due to presence of particulate matter: a white thread-like structure in the cartridge.
